## BERGOS AG INCLUDED IN THE "ELITE OF ASSET MANAGERS

## Swiss Private Bank receives highest grade in renowned ranking

Zurich. The Swiss Private Bank Bergos AG was awarded the highest distinction "summa cum laude" in the renowned "Elite of Asset Managers" competition in Munich on Monday evening.

Of 362 asset managers examined in Germany, Austria, Switzerland and Liechtenstein, 51 were rated as recommendable, including only three Swiss houses. For 19 years now, the Elite Report, published in cooperation with the "Handelsblatt", has provided an overview of the private banking scene in German-speaking countries. For this purpose, the asset managers were evaluated on the basis of 42 criteria, 800 portfolios and 600 practical cases were evaluated, and asset management contracts and company balance sheets were analysed.

"Almost in secret, a wealth manager has matured that evaluates and uses a wider field of vision for its clients from Switzerland. It is good that the old, once famous wealth culture still lives on. An ideal case for the clients, while others do not come out of the woodwork but only persist in the status quo," the jury said in its statement.
